Ordinances- Health & Safety – Settles

3. Village will talk to John Hoblit regarding legal advice to update the wording, rules and regulations for the Animal Ordinance. Also, see if he can attend a meeting to answer questions regarding Ordinances.

- Village received a complaint regarding old trailers on North end of town, 502 & 508 Illinois St. The village will look into back taxes and see if anything can be done to obtain the property.

Water - Shaffer

- Discussed down trees in Alley by David Isaac and White's Farm Equipment. Need to be removed and cut back. Randy will remove them from alley.
- Robin Landers inquired about getting tree in front of their home cut down. If trees are not dead, we will not cut down. If they need cut back or trimmed, we will do that for them.
- Randy is cutting 3 trees by Brie Hoepner's alley for better vision of road when leaving alley. Brie is okay with trimming them.
- Discussed starting a tree committee. Bryson motioned to start a tree committee, Brown seconded. Bristow, Shaffer and Brown will be the Tree Committee.
